ANNOUNCEMENT

APPOINTMENT OF RECEIVERS AND MANAGERS OVER SUBSIDIARIES

Further to the announcements made by Keppel Infrastructure Trust ("KIT") (collectively, "Previous Announcements") on:

- (a) 27 October 2021 in relation to the expiry of the standstill agreement between an indirect whollyowned subsidiary of KIT, Basslink Holdings Pty Ltd ("Basslink"), State of Tasmania and Hydro Tasmania; and
- (b) 12 November 2021 in relation to certain companies in the Basslink group ("Basslink Group")¹ entering into voluntary administration and the appointment of Adam Nikitins, Stewart McCallum and Colby O'Brien from Ernst & Young as voluntary administrators.

Unless otherwise defined, capitalised terms used herein shall have the same meanings ascribed to them as in the Previous Announcements.

Keppel Infrastructure Fund Management Pte. Ltd. (the "**Trustee-Manager**"), acting in its capacity as trustee-manager of KIT, wishes to announce that on 12 November 2021, Bob Yap Cheng Ghee and Toh Ai Ling of KPMG Services Pte. Ltd. had been appointed as joint and several receivers and managers over the entire issued and paid up share capital of Coral Holdings Australia Pty Ltd (which is one of the companies in the Basslink Group placed under voluntary administration) and the units in Premier Finance Trust Australia (which trustee is Nexus Australia Management Pty Limited, being one of the companies in the Basslink Group placed under voluntary administration), both of which are indirectly wholly-owned by KIT through CityLink Investments Pte Ltd ("**Receivership**").

As previously disclosed, there is no contractual recourse to KIT under the financing arrangements currently in place for the Basslink Interconnector and KIT does not rely on Basslink's cash flows for distributions. The Receivership is not expected to have any material financial impact on the distribution per unit of KIT for the financial year ending 31 December 2021.

KIT will make further announcements as appropriate, if and when there are material developments which warrant disclosure.
