City Energy Milestones Highlights of our 160-year Journey in Serving the Nation

1861 Founded as the Singapore Gas Company. 1862 Kallang Gasworks was constructed to manufacture piped town gas from coal for street lighting. 1864 The first gas lamps lit up Singapore's streets on 24 May 1864. 1901 Singapore Gas Company was bought over by the Municipal Commissioners to extend the gas supply network for street lighting. 1930s Households discovered the use of gas as an ideal source of fuel for cooking and for water heating. 1951 Singapore achieved city status and the Municipal Commission was renamed the City Council of Singapore with responsibilities of water, electricity, gas and street lighting. 1956 With electricity replacing gas street lighting, the last gas lamps in Singapore were extinguished. 1958 Fuel oil replaced coal in the manufacturing of piped gas and new oil gasification plants were built at Kallang Gasworks. 1960 The first Gas Showroom opened in City Hall, offering gas burners and cookers for hire. Customer base was 16,945. 1963 Public Utilities Board was formed as a statutory board to take over the

- 1966 Kallang Gasworks replaced its oil gasification plants with pollution-free naphtha gas-making plants.
- 1974 Empress Place Hawker Centre received piped town gas for the first time, the first to do so in a joint initiative with the National Environment Agency (NEA) to supply all hawker centres nationwide with piped gas.
- 1991 Natural gas arrived in Singapore for the first time. It was used to power the Senoko Gas Turbine Station.
- 1995 The Electricity and Gas Departments of the Public Utilities Board were corporatised to form Singapore Power. PowerGas Ltd was integrated into the new entity. PowerGas is in charge of managing the gas pipe infrastructure in Singapore.
- 1997 Official opening of the \$240 million Senoko Gasworks, with a high degree of automation and with a production capacity of 1.6 million cubic metres a day.
- 1998 Kallang Gasworks was decommissioned. All gas operations were officially relocated to Senoko Gasworks, which is still producing piped town gas to date.
- 2002 On 2 January 2002, City Gas Pte Ltd was formed as an entity divested by PowerGas Ltd and 100% owned by Temasek Holdings.
- 2003 Natural gas from South Sumatra, Indonesia, started to be piped to Singapore as partial feedstock to produce piped town gas.
- 2004 City Gas obtained its first natural gas customer in Tuas. In this year, City Gas also reached the 500,000th mark in terms of its piped town gas customer base.



- 2007 City Gas Trust was constituted as a private trust on 5 January 2007, a wholly owned subsidiary of CitySpring Infrastructure Trust, which was listed on the Main Board of the SGX-ST on 12 February 2007.
- 2008 City Gas recorded 600,000 customers using piped town gas.
- 2010 Awarded Singapore Business Superbrands 2010.
- 2011 City Gas celebrates its 150th anniversary.
- 2014 We achieved our 700,000th customer milestone.
- 2015 CitySpring Infrastructure Trust was enlarged on 18 May 2015 and renamed as Keppel Infrastructure Trust. We published a special edition book, the SG50 City Hawker Food Guide, to coincide with Singapore's 50th birthday. Copies of the book were given out during the City Hawker Food Hunt.
- 2017 We achieved our 800,000th customer milestone.
- 2019 City Gas Gallery relocated to Plaza Singapura #03-78. This embodied City Gas' commitment to providing low-carbon lifestyle solutions.
- 2020 City Gas signed a Memorandum of Understanding (MOU) with PSA Corporation Limited, Jurong Port Pte Ltd, Sembcorp Industries Ltd, Singapore LNG Corporation Pte Ltd, Chiyoda Corporation and Mitsubishi Corporation to develop hydrogen as an energy source for a low-carbon, clean and sustainable energy future for Singapore.
- 2021 City Gas disburses over \$1 million worth of piped gas rebates to more than 2,600 hawkers, to lend support as the Covid-19 restrictions have greatly affected hawkers' businesses.

City Gas rebrands itself as City Energy.
