**(B) Completion of acquisition of SND Tec Co., Ltd.**

KIT, through its indirect subsidiary, KD Environment Co., Ltd, had on 10 May 2024 completed the acquisition of SND Tec Co., Ltd. for an aggregate consideration of approximately KRW 0.9bn in cash. The aggregate consideration was arrived at on a willing buyer, willing seller basis taking into account the net liability value of SND Tec Co., Ltd., which was approximately KRW 0.2bn prior to acquisition.
