ANNOUNCEMENT PURSUANT TO RULE 706A OF THE LISTING MANUAL

Pursuant to Rule 706A of the Listing Manual, Keppel Infrastructure Fund Management Pte. Ltd., acting in its capacity as trustee-manager of Keppel Infrastructure Trust (“**KIT**” and the trustee-manager, the “**KIT Trustee-Manager**”), wishes to announce the following transactions for the financial period from 1 July 2024 to 31 December 2024.

ACQUISITION

Completion of acquisition of 50% equity interest in Marina East Water Pte. Ltd. (“MEW”) that entitles Keppel Infrastructure Trust to the entire economic benefit from MEW, which owns the Keppel Marina East Desalination Plant

The KIT Trustee-Manager wishes to refer to the announcements released on 30 June 2022, 18 November 2024, 26 November 2024, 6 December 2024, 11 December 2024 and 27 December 2024. KIT had, on 27 December 2024, completed the acquisition of 50% of the equity interest in MEW from Keppel Infrastructure Holdings Pte. Ltd. (“**KIH**”), which entitles KIT to the entire economic benefit from MEW (“**Acquisition**”). MEW owns the Keppel Marina East Desalination Plant. As disclosed in the circular to unitholders of KIT (“Unitholders”) dated 26 November 2024 with respect to the Acquisition (“Circular”), based on an enterprise value of approximately S\$323 million, KIT had extended a non-interest bearing loan of S\$35 million to MEW and paid S\$2 as consideration for the acquisition of 50% of the equity interest in MEW. In connection with the Acquisition, MEW became an associated company of KIT.
